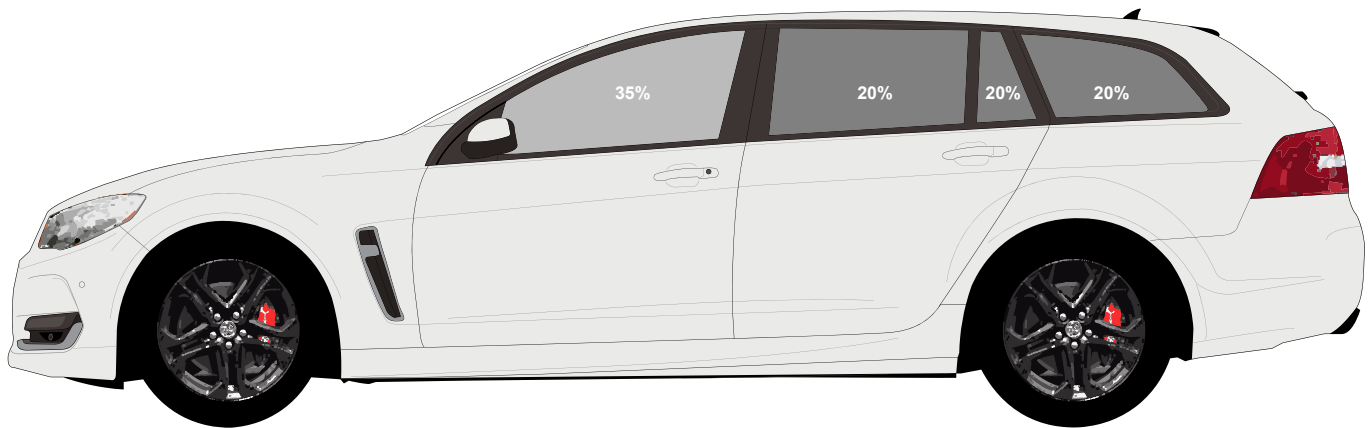




Specifications

As a standard, The Vision Group WA tints vehicles and machinery in 35 grade charcoal window film. This film is the darkest legal and is acceptable both on and off road. It is also approved for mine specific machinery and vehicles.

20 grade film may be applied to windows behind the B pillar provided that rear vision mirrors are fitted to the exterior on each side of the vehicle. All windows forward of the B pillar must be no darker than 35 grade. Tinted films are not allowed on the main part of the windscreen. A visor strip may cover no more than 10% of the windscreen area.

Care of Window Film

Window film is applied to the interior windows of your vehicle. You may continue to wash the exterior of your vehicle as per usual. However, you must pay particular attention to cleaning and care of the interior film.

**** DO NOT WIND WINDOWS DOWN FOR A PERIOD OF 48 HRS AFTER FILM HAS BEEN INSTALLED****

Do not use harsh chemicals or abrasives to clean the interior glass. We recommend using warm soapy water (dishwashing detergent) and a soft microfibre cloth to clean the glass. Avoid sharp objects resting on the window as this will scratch the film.

Product Warranty

Our supplier warrants against Llumar film bubbling, cracking, delaminating, demetalising and fading for a period of 10 years. The Vision Group WA shall, at their discretion, either repair or replace any part, which upon examination proves to be defective in material or workmanship only. The Vision Group WA reserves the right to charge for the labour component after two years following original installation if product is proven faulty.

Workmanship Guarantee

We guarantee our film installations for 12 months. We will address any installation issues for a period of 12 months from the day of installation. All liability for loss or damaged whether consequential or otherwise arising from negligence or from any cause whatsoever is hereby excluded. No responsibility or liability is assumed for the deterioration of the film due to normal wear and tear, negligence, abuse or accidental damage.

Automotive window tinting warranties are not transferable.

All claims must be made within the 12 month in-house warranty period and are subject to approval by The Vision Group WA authorised representative. Please ensure that your invoice is retained in order to claim warranty within the first 12 months. If you do not have a copy of the invoice, the warranty claim will not be approved. This warranty is the sole warranty made by The Vision Group WA in regards to our graphic products. The Vision Group WA makes no other warranties, expressed or implied.
